RELEASE AND NOTIFICATION AND ASSUMPTION OF RISK

1. I acknowledge that I am physically fit to snorkel and I will not hold Teralani Sailing responsible if I am injured as a result of heart problems, lung problems, or other illnesses or medical problems which may occur while snorkeling or while a passenger on any vessel used for a snorkel trip. I will assume responsibility for any photographic equipment I bring aboard the vessel.
2. I understand that due to the nature of the ride and varying sea conditions that ocean rafting tours are not recommended for individuals who are pregnant or have physical conditions, such as back or neck problems, which could be aggravated by sudden movement of the vessel in a seaway and I specifically assert that I am free of such conditions. I confirm that I have been NOTIFIED of the danger associated with ocean rafting and am physically fit to participate in this event.
3. I understand that boating and snorkeling have inherent risks and dangers, including but not limited to risk associated with perils of the sea and equipment failure and I specifically assume such risk.
4. I will snorkel with a buddy and will at all times remain within close proximity to my buddy such that if either of us should be in distress, the other will be able to render or call for assistance. If I am a poor or a non-swimmer, I will notify the captain immediately upon boarding and will follow the captain's directions for my safety.
5. I will comply with all written or verbal safety or emergency instructions including but not limited to:
 - a. Avoiding close proximity to sharp coral reef especially where wave action could be hazardous
 - b. Avoiding areas know to have currents which could be hazardous
 - c. Keeping reasonably close to and aware of the position of the vessel at all time by looking up periodically and remaining responsive to any signals from captain or crew.
 - d. Staying clear of the motors when approaching the vessel in the water.
6. I understand that Honolua Bay is a Marine Life Conservation District which prohibits standing on, touching, or damaging the coral reef and prohibits taking or harassing marine life.
7. It is specific intention by this instrument to exempt and relieve Teralani Sailing, and their officers, agents, operators, crew, servants, and employees from any and all liabilities for personal injuries, property damage or wrongful death caused by negligence or otherwise, and I assume all risk in connection with snorkeling and boating activities or instructions.
8. In the event I show signs of distress or call for aid, I would like assistance and will not hold Teralani Sailing, its crew, vessel, agents, or passengers responsible for their actions in attempting the performance of a rescue or first aid.
9. Should Teralani Sailing or anyone acting on their behalf be required to incur attorney's fees and cost to enforce this agreement, I agree to indemnity and hold them harmless for all such fees and cost.
10. I have read the foregoing in its entirety and agree to the terms and conditions herein above set forth on behalf of myself, my heirs and personal representatives.
